In accordance with federal rules, CFASE does not accept contributions from individuals who have direct contracts with the federal government. Contributions are not deductible as charitable contributions for federal income tax purposes. NTMA only accepts PAC contributions from U.S. citizens or green card holders who are principals and senior management employees of companies that have given written solicitation permission as required by federal law. Federal law requires political committees to report the name, mailing address, occupation and employer for each individual whose contributions aggregate in excess of \$200 per election cycle.**
